From Our Leadership

The German philosopher J.W. von Goethe said "The only constant is change," and 2006 was a banner year of change for the **Epilepsy Society of Southern New York and Capabilities Partnership, Inc.** By change, I mean progress; we restructured our Education Department and Vocational Services Department and added a new department serving the Traumatic Brain Injured (TBI) population. Part of our program expansion with TBI is our Structured Day Program (see page 3 for more details). In addition, we have begun an Intensive Behavioral Program (IBP) for the TBI population which involves clinical interventions that are necessary to improve and enhance the individual's life and well-being. This is done by engaging the individual and inviting them to participate in an active role. In doing so, one might begin by identifying what is meaningful in their life as well as to identify their strengths and accomplishments. This would provide a foundation from which to build the clinical supports. These supports would assist the individual in developing and sustaining positive routines that increase their independence in the community.

Our education department provided 152 in-services to allied agencies, schools, and various other companies and individuals in the seven county area and in northern NJ. The department has recruited a **Rockland County Girl Scout Troop**, as well as the **Rockland Community College Performing Arts Department**, to be trained to assist with our Kids On The Block puppetry program.

Our social events for consumers has increased greatly thanks to the **Chris McCarthy Scholarship Fund**. As you will read in this newsletter, we also have had great success with our fundraising, thanks to our **Fundraising Committee**, chaired by **Carl Capuano** working with **Leslie Slender**, our **Associate Director**.

Our **Board of Directors**, **Professional Advisory Board**, and our **Consumer Advisory Council** are all comprised of volunteers who give oversight to me and our staff, review our programs, support our fundraisers, and provide expert advice on policy and managing the agency. Their participation is priceless and I am very grateful to them for their dedication to our mission.

Self-Esteem in Teens With Epilepsy

It has long been recognized that the adolescent years are a time when young people are unsure of themselves and how they fit into the world. Teens with epilepsy may have to work harder to accept themselves at this stage of their development. You can help.

Self-esteem is a value judgment we make about our own worth, an evaluation that affects everything we think and do. Teenagers are famous for questioning themselves and the world in order to build an all-important self-understanding and the part they will play on the stage of life. In the meantime, they seek to be like everyone else in order to ease the anxiety of independence.

People with low self-esteem have a negative outlook on life. They may feel powerless; successes may not come easily; little things may upset them; challenges appear as threats. They isolate themselves from peers and fear being different from others. The unpredictability of seizures and the lack of control that goes along with them can result in feelings of uncertainty in anyone. In teens, it can be an uphill climb.

Teachers and parents need to help their teens develop a solid foundation of self-esteem. To achieve this, the following factors should be addressed:

- *A sense of significance:* Show teens they matter. Listen and offer acceptance and warmth.
- *A sense of competence:* Help teens realize they are capable by setting realistic and appropriate expectations, making sure you don't set those expectations too low.
- *A sense of individuality and connectedness:* Encourage participation in activities that highlight their special talents and abilities.
- *A sense of realism about oneself and the world:* Having a seizure in school is not a major catastrophe. Help teens learn about others who cope with epilepsy and live normal, even outstanding, lives. Focusing on the reality of each situation instead of the fear will discourage manipulative behavior.
- *A solid sense of values and ethics:* The ability to decide what is important and what is not; what is right and what is wrong; may be the most decisive factor in teens' self-esteem. Be their model by living up to the values you claim to have.

You can make the difference in a teen's ability to navigate the combined stresses of adolescence and a seizure disorder. And, if you need it, help is not far away. Call the Epilepsy Society of Southern New York at 800-640-0371.

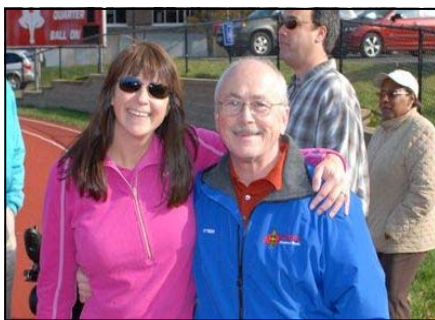

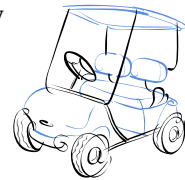


McCarthy Friends & Family Golf “Fore” Fund

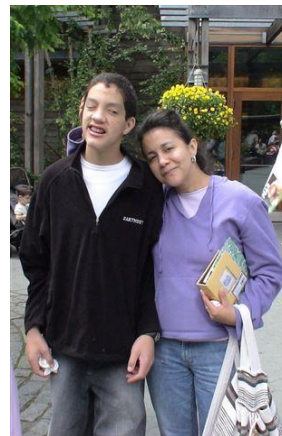


2006 Chris McCarthy Scholarship Fund Winners



The Chris McCarthy Scholarship Fund made dreams come true this summer, awarding 13 summer camp scholarships!

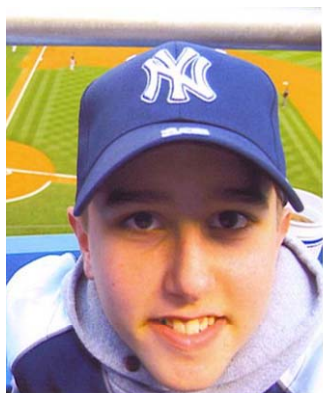

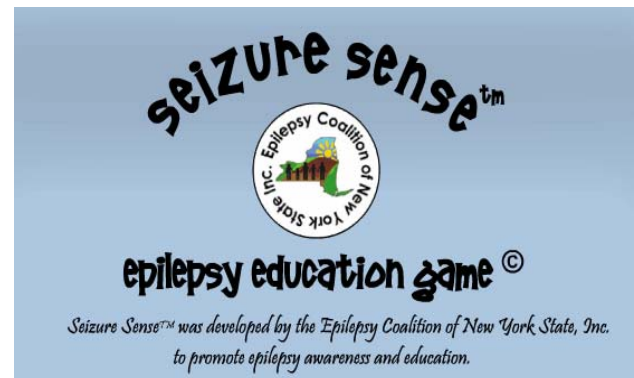
